ICE Preparation Checklist for Minnesota Nonprofits

This checklist is designed to help Minnesota nonprofits understand and prepare for potential visits from Immigration and Customs Enforcement (ICE). It is based on guidance from the Minnesota Attorney General, the Immigrant Legal Resource Center (ILRC), and legal advocacy organizations.

1. Understand Official State Guidance

__ Review the Minnesota Attorney General's May 2, 2025 public advisory on ICE enforcement limits and warrant requirements.

2. Distribute 'Know Your Rights' Materials

__ Provide bilingual ILRC Red Cards to staff, volunteers, and clients to inform them of their rights.

3. Host 'Know Your Rights' Training

__ Incorporate Red Card role-playing in workshops or staff meetings for practical application.

4. Maintain Physical Readiness

__ Stock Red Cards in visible, accessible locations such as entrances, reception areas, and community rooms.

5. Verify Free Card Availability

__ Use ILRC's official ordering system for free Red Cards and avoid unauthorized sellers.

6. Inform Clients & Visitors

__ Post flyers and informational posters about rights in multiple languages at entrance points.

7. Establish Response Protocols

__ Designate a staff member to manage ICE responses and maintain connections with immigrant legal services.

8. Know Legal Entry Standards

__ Train staff that ICE cannot enter without a valid warrant or consent, and how to verify such warrants.

9. Use Red Card Scripts

__ Teach everyone to say: 'I do not wish to speak. I do not give permission to enter without a warrant signed by a judge.'

10. Document Encounters

__ Record agent names, date, time, and whether a warrant was presented during any ICE visit.

11. Share Resources Externally

__ Include Red Card images and rights language in newsletters, pamphlets, and community education materials.

12. Stay Networked & Informed

__ Monitor ILRC and legal partner updates for policy changes and language expansions.
