MCN strives to provide educational events, networking opportunities, and publications that center equity and respond to the expressed needs, interests, and experiences of individual organizations to support the growth, health, and future of the sector and its people. In 2025, MCN sponsored approximately 97 public events with over 9,120 total attendees. The majority of MCN's workshops were offered virtually in response to member feedback and choice. Our 2025 Annual Conference was held with registration across the nonprofit and philanthropic sectors of 1,300 people. The Annual Conference, Nonprofit Leadership Conference, and Nonprofit Fundraising Conference each sold out. Our Finance and Sustainability Conference remained virtual and had 447

MCN builds the capacity of nonprofit leaders to be confident and competent voices on issues impacting their constituents and communities by providing them with workshops, briefings, and other informational resources. MCN's Minnesota Budget Project educated nonprofits, decision-makers, the media, and the public on budget, tax, and economic policy issues through a range of activities. In 2025, MCN offered public policy training and information series attended by several hundred participants that included presentations on nonprofit advocacy, state agencies, as well as conversations with elected and appointed officials including federal leaders on policy and administrative actions that impact nonprofits and the communities they serve.

In 2025, 2,119 charitable organizations, 245 businesses, 48 individuals, and 4 foundation memberships contributed dues to support the full array of MCN's work priorities. MCN members receive discounts on publications, in-person and virtual workshops, and full-day conferences. Additionally, nonprofit members have access to free postings on MCN's highly trafficked job board and up to two free resource publications from MCN's available catalog. In 2025, MCN members posted 9,197 free staff, board, volunteer, and intern openings on MCN's job board. Through the use of free member publication vouchers, MCN nonprofit members requested and received 728 free copies of regularly updated publications in 2025. Publications accessed

The Minnesota Council of Nonprofits (MCN) strives to advance the strategic objectives of the organization by providing competitive and equitable wages and benefits in order to attract and retain outstanding staff, be seen as a leading employer in the nonprofit sector, and live organizational values of greater equity and transparency. MCN develops salary bands for different levels of staff positions based on market data from MCN's biennial Salary & Benefits Survey. The salary bands are adjusted every two years aligned with the most recent market data. MCN's personnel committee of the Board of Directors reviews proposed adjustments to salary bands, and MCN's full Board of Directors approves changes. MCN's Board of Directors is responsible for approving the compensation of the President & CEO and, when applicable, the other persons in a position to exercise substantial control over the organization's resources. The Board is responsible for ensuring the President & CEO's compensation responds to market conditions, working to ensure equitable compensation across the organization, and ensuring the President & CEO's compensation falls within the current approved range for the President & CEO salary band. The Board approves the compensation of the President & CEO annually and in advance of any change in compensation, and any decision must be recorded in board meeting minutes. When determining the reasonableness of the compensation package paid to the President & CEO, the Board should ensure that the individuals involved in making the compensation recommendation, including consultants, do not have a conflict of interest with regard to the executive.

In 2025, MCN shared information widely on Minnesota's nonprofit sector, demonstrating the economic impact of nonprofits on the state's economy and challenges faced by nonprofits through three published research reports, public presentations, media citations, and more. MCN also conducts nonpartisan research and analysis on tax, budget, and economic issues through the Minnesota Budget Project. The Minnesota Budget Project's analysis particularly focused on state and federal policy choices and economic trends that impact low- and moderate-income Minnesotans and communities of color, budget and policy choices that impact Minnesotans' access to prosperity and economic opportunity, the contributions of Minnesota's immigrants to the economy and local communities, and progress toward a fair and sustainable tax system.

Advocacy: MCN undertakes nonpartisan advocacy efforts to strengthen the nonprofit sector and its ability to serve communities throughout Minnesota. MCN's major advocacy efforts in 2025 included advocacy in support of public availability of data on the nonprofit sector, and federal charitable giving tax incentives, as well as educating lawmakers on the impacts of reforms to state grantmaking and oversight of state grants to nonprofits. MCN's Minnesota Budget Project identifies and advances public policies to make Minnesota a place where all can thrive, especially in the areas of tax, budget, and economic policy. The Minnesota Budget Project's 2025 federal and state policy priorities included protecting Minnesotans' inclusive access to basic needs services (including affordable health care and food assistance) and educating on the harm to Minnesotans' well-being that would occur if funding for these services is eroded by large tax cuts.
